- bank or building society official;
- civil servant;
- minister of religion; or
- police officer.

This person must meet all of the following criteria:

- they must have known you for at least 2 years;
- they must not be related to you by birth or marriage;
- they must not be in a personal relationship with you;
- they must not live at the same address as you;
- they must hold a current UK or ROI passport; and
- they must be currently living in the UK.
